WHEREAS the AMPA Regulations were amended on **September 16, 2025** to increase the interest free benefit for all 2025 advances on canola from \$250,000 to \$500,000;

THEREFORE in respect of an advance made on canola to the producer by the Administrator for the 2025 Program Year, and AMPA Regulations subsequently being amended, the parties hereby agree as follows:

- The Government of Canada will pay the interest on the first \$250,000 in advances and effective **September 16, 2025**, the Government of Canada will pay the interest on an additional \$250,000 in advances on canola only.

PRODUCER DECLARATION

In light of the above, I am requesting an additional advance in the amount of \$_____.

1. For the purposes of the above:
 - a. I understand that the additional advance I am requesting may be subject to the Administrator receiving additional financial authority via the amendment of the Advance Guarantee Agreement.
 - b. I authorize the Administrator to assign an account type (interest free or interest bearing) to specific commodities on the advance in order to maximize the interest free benefit.
 - c. I acknowledge that all repayment of advances shall be allocated first towards the balance of the interest free account before reducing the balance of the interest bearing account.
 - d. I acknowledge that I remain responsible for paying the interest which accrued prior to **September 16, 2025**, on canola advances over \$250,000, at the rate defined in the original repayment agreement.
2. I have completed, signed and attached a new Priority Agreement for the additional advance amount indicated above.
3. I agree to comply with all of the terms and conditions included in the original Application form and Repayment Agreement and this amending agreement.
